GRANT FUND PROGRAM GRANT FUND APPLICATION GUIDELINES & INFORMATION

WHAT IS THE UKRAINIAN CATHOLIC FOUNDATION GRANT FUND PROGRAM?

When the Sheptytsky Institute was sold, the proceeds of sale were used to establish the Ukrainian Catholic Foundation Grant Program. The investment income generated by this fund will provide grant funds to Parishes/Missions and Eparchial Organizations approved by the Eparch of the Saskatoon Eparchy. The Ukrainian Catholic Foundation of Saskatchewan (UCFSask) has been mandated to manage this fund and administer the grant funding program for the Eparchy.

WHO IS ELIGIBLE TO APPLY FOR THE UCFSASK GRANT FUND?

The Ukrainian Catholic Foundation of Saskatchewan (UCFSask) will consider applications for grants from Parishes/Mission under the auspices of the Eparchy of Saskatoon and from Eparchial Organizations approved by the Eparch for projects/initiatives that align with the Foundation's mission and purpose.

UCFSask's mission is to:

- Promote the cultural, social, educational, and spiritual initiatives, policies, and objectives of the Eparchy among Ukrainian Catholics in the Province of Saskatchewan; and
- Assist, financially or otherwise, any organizations that propagate the cultural, social, educational, and spiritual well-being of Ukrainian Catholics in the Province of Saskatchewan in accordance with the initiatives, policies, and objectives of the Eparchy.

GRANT GUIDELINE CONSIDERATIONS

- 1) Applications for the grant should also be guided by the recommendations for action from the Eparchial 2014 SOBOR Document The Vibrant Parish.
- 2) Grant funding will be awarded for definite purposes or specific projects/initiatives covering a specific period.
- 3) Based on priorities and funds available, UCFSask will identify the size and number of grants, and the deadline for submissions through advertising on the Foundation's website, Eparchial website, Parish Bulletins, and other publications as deemed appropriate.

- 4) As a basic guideline for grant funding, UCFSask will establish priorities for support each year based on needs assessment and diversification of purposes.
- 5) The organization applying for grant funds will need to demonstrate need, the likelihood of effectiveness of the project/initiative and potential to serve as a model to others.
- 6) The applicant organization should demonstrate a commitment to the project/initiative through a contribution of human and/or financial resources.
- 7) Applications for grant funding should include a budget and/or financial plan providing how the funds will be spent.
- 8) Applicant organizations/groups seeking funds must demonstrate that they have a strong and committed staff and/or volunteers and capacity to effectively manage project resources.
- 9) Appropriate support from other funding sources may receive preference for grant funding.
- 10) UCFSask will make grants available once per year. However, the Board of Directors will consider special emergency situations between the normal granting time at the request of the Executive Director.
- 11) Changes to project scope from the original application must be approved by UCFSask Board of Directors. In some cases, organizations may be required to submit a new application outlining the new project scope.
- 12) Grant recipient organizations will need to submit a report to UCFSask after the completion of the project/initiative providing information on how the grant funds were spent and the resulting benefits.
- 13) Applicant organizations will need to include a letter of support from the Parish Priest with the grant application.
- 14) As a recipient of any grant funding consideration, the applicant organization must be a registered charitable organization within the Eparchy of Saskatoon.

WHAT WILL NOT BE FUNDED BY THE "UKRAINIAN CATHOLIC FOUNDATION GRANT FUND PROGRAM" •

Debt retirement or reserves, and mortgage pay-downs.

- General fundraising campaigns.
- Support for an organization's core operating expenses.
- Where the activities of the applicant organization are discriminatory or service the interests of the members, employees, or constituents of those organizations to the exclusion of the community at large.
- Any requests for purposes that are deemed to be illegal, immoral, or not in the best interests of the Eparchy of Saskatoon.

HOW WILL GRANT FUNDING BE ALLOCATED?

To ensure that the total amount of the grant available for distribution for the year would be allocated throughout the Eparchy as equally as possible, the total grant amount of the grant funding available for distribution will be allocated as follows:

- Eligible Eparchial Organizations will be allocated 10% if the total amount available for distribution for the year.
- The balance will be allocated to Parishes/Missions based on the number of Parish Families within each Deanery.
- Using this formula, the grants funds available for distribution for 2023 will be allocated as follows:
 - Eparchial Organizations: 10% (\$5,000)
 - Saskatoon Deanery: 48% (\$21,600)
 - Yorkton Deanery: 52% (\$23,400)

The amount of grant funds available for distribution in 2022 will be \$50,000.00

- If the UCFSask does not receive any grant applications from one of the two Deaneries or Eparchial Organizations, or amounts not enough to use up apportioned amount, and if that Deanery does not provide a formal request for a deferral that would be approved by the Grant Review Committee, the total grant funds available for distribution would be allocated to the other Deanery. This ability to defer will not be available to the Eparchial Organizations.
- A Deanery may request an extension for funds allocated in a particular year if no grant funding
 applications were received from that Deanery, or if the entire allocation was not disbursed. The
 request for extension would need to be for a named specific initiative and receive approval from
 the Grant Review Committee.
- The Grant Review Committee reserves to right to change the grant allocation guide/formula based on need and special considerations.

• Should a portion of the funds available for distribution not be distributed, the amount left over will be transferred to the next year. This amount would then be added to next year's total and be available for distribution to all the Deaneries and Eparchial Organizations on the same prorated basis as indicated above.

PROCEDURE/PROCESS/TIMELINES

The USCSask Board of Directors will establish procedure/process and timelines to be followed to provide consistent and uniform format for the Faithful of the Eparchy. The purposed format is as follows:

- Applications for Grants will close on April 15th of each year.
- The Grant Review Committee will adjudicate applications by May 1st, and make recommendations for distribution to the UCFSask Board of Directors
- The grants will be disbursed to the successful applicants by May 31st.
- List of the grant recipient organizations receiving grants, including the amount of the grant and the purpose, will be publicized on the UCFSask's and Eparchial website, Parish Bulletins and other appropriate publications as deemed appropriate.
- The Executive Director will provide a report on annual activities of the Committee at the UCFSask Annual General Meeting as part of the Foundation's Annual Report.
